The Water Well Field Project – This project will have incremental steps. Once we do the wells and they are ready, then see how much water they collectively produce, then the chemistry work will be done to see what water treatment requirements will be for the water. Next there will be an agenda item for the treatment costs and the waterline, we are already the route lined out and where the waterlines and standpipe will be placed. We are looking at ways to reduce some of the costs, since the next lowest bidder was higher than the original engineering cost estimate. We will be working with the contractor before the contract is before the council for approval.

The 2022 CDBG Waterline Replacement – This project is 80% complete. They are doing the water line tie end on East North Avenue while School is out for the holiday. Ryan McDonald is the project manager for all the projects in town.

The Waterline Replacement in the Chikaskia River is complete. The is a certificate of completion is ready for signature.

The ODOT Waterline Relocation is under Task Order #2 on the Master Services Agreement.

Task Order #1 has not been executed this is for the renovation of the Old Armory.

Trust Attorney Lee Stout had nothing further to report.

<u>Trust Manager Kirk Henderson</u> reported that we have all the easements for the waterline projects except for the 1½ acres for the new standpipe at the new Well Field Project North of Holiday Lighting. We are negotiating with the landowners on this purchase but since we started this project the costs have gone up.
