The governing body of the City of Tonkawa encourages attendance in City meetings by all interested persons. Official action can only be taken on items which appear on the agenda. The public body may adopt, approve, ratify, deny, defer, recommend, amend, strike, or continue any agenda item. When more information is needed to act on an item, the public body may refer the matter to Staff or back to Committee or the recommending body. Under certain circumstances, items are deferred to a specific date or stricken from the agenda entirely.


13. Consider and vote upon establishing an ordinance prohibiting new marijuana grow facilities from opening within the city limits of City of Tonkawa.
